1. Introduction

Since the last Sheffield Health and Care Partnership Board met, the Sheffield Oversight Committee has met twice on 23 February and 23 March.

2. Summary

Place Financial Position at Month 10 and 11 – a detailed report was submitted outlining the month 10 position that was split into two parts, the first being the financial position of Sheffield Partners, and secondly information on Sheffield ICB position. The month 11 position was provided as a verbal update, and it was reported that South Yorkshire ICS are planning to report a breakeven position for 2022-23. Focus has now moved to the financial plans for 2023-24. The Committee agreed that Sheffield City Council would triangulate their financial challenges with those of the NHS.

Place Performance Position – it was reported that the performance report is work in progress and awaiting the outcome of discussions regarding Sheffield's priorities and milestones, which will be agreed by the Sheffield Health and Care Partnership Board. Discussions have been held with the Director of Public Health as to how the report can be adjusted to include impact on health outcomes. (see appendix 1).

Place Quality, Patient Safety and Experience – a report was submitted to the February meeting, with no material changes to report by the March meeting. Terms of Reference are being produced for Quality Review Groups for the three main NHS providers, ie; Sheffield Teaching Hospitals, Sheffield Children's Hospital and Sheffield Health and Care Trust. The focus of the Terms of Reference will move from CQC headlines to quality improvements and deep dives, which will be implemented from May/June 2023. Deep dives will also be held within the Local Authority and how that fits in with delegation to the NHS England Quality Boards.

2023-24 National Planning Updates – the final plan is due to be submitted by the end of March 2023 and there are a range of elements within the planning ask that Sheffield 'place' will need to work on over the next 12 months.

HCP Place Risk Register – this will be produced following agreement of the Sheffield 'place' priorities.

3. It is recommended that the Sheffield Health and Care Partnership Board note the update from the Sheffield Oversight Committee meetings.

Sheffield Health and Care Partnership Board are asked to note that a future proposal may be presented which brings the Transformation and Oversight Committee meetings together.
