1. BCF Overview

The Better Care Fund (BCF) is one of the government's national vehicles for driving health and social care integration. It requires integrated care boards (ICBs) and local government to agree a joint plan for using pooled budgets to support integration, governed by an agreement under section 75 of the NHS Act 2006. The BCF programme underpins key priorities in the NHS Long Term Plan by joining up services in the community and the government's plan for recovering urgent and emergency care (UEC) services, as well as supporting the delivery of Next steps to put People at the Heart of Care. The BCF facilitates the smooth transition of people out of hospital, reduces the chances of re-admission, and supports people to avoid long term residential care.

The delivery of the BCF will support 2 key priorities for the Sheffield health and care system that align with the 2 existing BCF objectives:

- improving overall quality of life for people, and reducing pressure on UEC, acute and social care services through investing in preventative services;
- tackling delayed discharge and bringing about sustained improvements in discharge outcomes and wider system flow.

2. BCF objectives and priorities for 2023 to 2025

The Better Care Fund plan aligns to all six of the commitments in the Adult Social Care strategy and Partnership priorities with two primary objectives:

Enable people to stay well, safe and independent at home for longer

The Sheffield plan focuses on taking steps to enable person centred care which promotes independence and addresses health, social care and housing needs of people who are at risk of reduced independence, including at risk of admission to hospital or long-term residential care.

Provide the right care in the right place at the right time

The Sheffield plan places emphasis upon ensuring people are discharged to the right place, at the right time, and with the right support that maximises their independence and leads to the best possible sustainable outcomes. This includes continued implementation of the High



















Impact Change Model for Transfers of Care, which is the basis of the Better Care Fund requirements around supporting discharge.

The Better Care Fund has four funding streams at a national level:

- minimum allocation from ICB Allocations towards jointly commissioning social care services;
- disabled facilities grant paid via a Local Authority grant to enable housing and equipment adaptations;
- social care funding (improved BCF or iBCF) paid as a local authority grant;
- ASC Discharge Funding.

In 2023 to 2024, the discharge fund will focus on growing social care capacity in ways that have the greatest possible impact on:

- reducing delayed hospital discharges;
- planning services sufficiently far in advance to enable providers to make appropriate workforce capacity plans;
- learning from evaluation of the impact of previous discharge funding;
- improving collaboration and information sharing across health and social care services.

Full details of the 2023 to 2024 Discharge Fund conditions are outlined in the <u>planning</u> requirements.

3. Better Care Fund 2023/25 Plan

On 4 April 2023 the Department of Health and Social Care published the 2023 to 2025 <u>Better Care Fund Planning Requirements</u> setting out the core requirements included the development of a narrative plan explaining current programme delivery against local objectives, explanation of local structures and governance and confirmation of agreed expenditure in compliance with the requirements of the fund.

System partners have supported the development of the attached draft plan that was submitted to for NHS England feedback on 23 May. The final plan is due to be submitted on 28 June 2023. The sign off timeline is included below for assurance.

4. BCF metrics for 2023 to 2025

Detailed discussions are taking place with metric leads and targets are in development for the following metrics requested in 2023/24:



















- discharge to usual places of residence;
- new: discharge metric ahead of winter;
- admissions to residential and care homes;
- unplanned admissions for ambulatory sensitive chronic conditions;
- the proportion of older people who were still at home 91 days after discharge from hospital into reablement or rehabilitation services; and
- new: emergency hospital admissions due to falls in people over 65.
